Once again, it was a privilege and blessing to attend this year's CBOQ Annual General Assembly as a delegate, along with Rev. Ruth Bartlett. The theme was. **ABC** ... **Associating** (Matthew 16: 13-20 & 1Cor. 14: 26-33), **Belonging** (John 3: 16 & Romans 3:22-26), **Called** (Acts 9: Jesus calls disciples.). The Assembly is an opportunity to receive an update of CBOQ activity, a chance to network with other Churches and support services, to learn, to praise and of course, meet up with old friends and meet new ones.

There were three plenary sessions based on the ABC theme. The first, presented by Sam Chaise, was **Associating**. With years of experience with CBM, CBWC, Christie Refugee Centre, and Carey Theological College, he explored with us the need for the Church in Canada to reassess its model and mission in light of changing times. The second session, **Belonging**, was presented by Rhonda Britton, Senior Pastor of New Horizons Baptist Church on the East Coast. She expanded on how our social structure has been built on division and segregation, perpetuating disparities. She questioned ... "Can the Jesus in you see the Jesus in me?" ... we are called to be transformed, to strive for justice, unity in Christ and equity. This journey requires intentional effort to dismantle divisions, to challenge social norms and actively promote a sense of belonging. The last session was presented by our newly appointed Executive Director, Rev. Leanne Freisen. She used the example from Mark 10. 46-52, the story of the call of Bartimaeus, an unlikely recipient of Jesus' call. Jesus saw beyond appearances. He calls every one and gives everyone a unique purpose. She shared her personal faith journey and her surrender to God's plan.

The delegates were offered a selection of Learning Sessions, presented in small groups by wonderful leaders. Subjects included ABC of the New Testament, The ABC of being Anti-Racist, The Church and the Marketplace, Parenting, CBOQ Financial Support for Churches, Re-envisioning Buildings and Spaces, Urban Sherpas and Suburban Guides, Retiring not Expiring, and Conversations on Women and Men in Flourishing Partnerships in Ministry.



The AGM brings together member Churches and Associations each year to address important matters and establish direction for the CBOQ Board and staff, focusing on resources, leadership development, fostering partnerships and strengthening identity. We heartily welcomed Logos Baptist Church, Oakville as new members. Board President, Craig Rumble, presented the work done on the CBOQ Membership Review Process, the review of Core Documents. The Bylaw Review Missional Team proposed revisions which include the motion that affirms the priesthood of all believers, both men and women.

The Financial Report was presented by Koon Wah. She reported that 94% of the revenue target was achieved, but expenses outweighed revenue. Balance achieved from inter-fund transfers. The primary objection is to give back to churches and partners through grants and supports. It was noted that 21 churches closed in the past five years with four more this year. A motion was passed to accept this Report.

Rev. Friesen was unanimously ratified as the new Executive Minister of CBOQ. She shared her personal faith journey and aims to encourage and empower staff and Board Members, dreaming big for CBOQ. She vowed to celebrate the identity and potential of each church.

The afternoon included the recognition of new ordinands, newly transferred credentials and the Children and Family Certificates. Of note was the celebration of Woodstock Baptist Church and their 200 years of service in their community.

The Nominations Committee Report was presented and accepted. Then, Rev. Friesen expressed gratitude for Rev. Tim McCoy for his past service. He confirmed that many efforts were made to strengthen Baptist identity and policy, innovate and share new church models, focus on future pastors and establish sustainable financial models with supporting resources.

The question of welcome of all people to share in worship was discussed at length. A motion was passed to "welcome but not affirm nor endorse any sinful lifestyle identified in the Word of God."

When the Worship Team asked guest preacher Rev. Joe Elkerton for a meaningful Land Acknowledgement he suggested this prayer:

Creator, you made all people of every land. We dwell on many traditional lands as we gather this day and we acknowledge with respect that our church rests on the traditional land of the Wendat, the Haudenosaunee and the Anishinaabe Nations, including the Mississaugas of the Credit First Nation, the first people of this land. We are also thankful for the gifts of the People of the land. Creator let us be of good mind to reconcile the mistreatment of this land and those who have been displaced. With thankful and respectful hearts we pray in your name, your son the Peacemaker and the Sacred Spirit. Amen.

Calvary Finances

The first six months of 2023 Calvary's expenses continued to exceed income as our space was not fully utilized and rental income has been lower than in years past. This was anticipated in our approved budget for the year. I am pleased to report that we will be entering into an agreement with Leroux for the school to use additional space beginning September 1st. The new income, combined with additional user income over the summer months, means that we are close to achieving a balanced budget beginning this summer. We are grateful for this development.

Calvary Renewal Loans - Investment Certificate Opportunity

At the April 23, 2023 Huddle, the congregation of Calvary agreed to raise funds to support its ongoing operations. We have since learned that the buildings at 72 Main Street are in need of immediate repairs expected to cost as much as \$50,000. In order to continue to support worship and to provide the programs in our community such as seniors' and the Grace Pascoe Care Centre food bank, it is important that we maintain the building and infrastructure that we have.

The Treasurer, supported by the leadership, is proposing to offer investment certificates for three-year terms at a rate of 4%. The interest rate compares favorably to CBOQ certificate rates.

The report from Helena Bergen, Executive Director of CBWOQ, shared a video that showed the variety of ways they serve Baptist women. We also heard from Stanley Porter, who provided an update of McMaster Divinity College.

It was a weekend of business, praise and worship, networking and togetherness. We closed with the celebration of the Lord's Supper and prayer for each other.

At Calvary we are grateful for the support and encouragement we have received from CBOQ and are looking forward to what God has in store for us all as the body of Christ.

Treasurer & Interim Moderator Report

Calvary Renewal

In 2019 the Church struck a Renewal Team to address the challenges associated with a small and aging congregation with significant real estate holdings, an aging infrastructure and attendant financial challenges. In June 2021, the congregation accepted a report of the Renewal Committee which made a number of recommendations, including establishing two committees:

- Ministry Strategy Committee tasked with clarifying Calvary ministry foci and to investigate partnerships
- Building Committee tasked with investigating valuations and opportunities for 72 Main Street

Through this period, the congregation was asked to pray and support these teams in their efforts. The objective was to arrive at an integrated plan for ministry, real estate and financial resources, ideally by June 2023 in order to begin planning to upgrade the building to meet accessibility standards.

Ministry Strategy Committee

The congregation received the preliminary report of the Ministry Strategy Committee in June 2022, which identified the following ministry foci:

- 1) Worship, prayer and discipleship
- 2) Serving and supporting seniors
- 3) Neighborhood outreach through the Grace Pascoe Care Centre (current emphasis being the Food Bank)

This information was provided to the Building Committee, so that they could take into account the real estate needs for those ministry priorities.

Building Committee

The Building Committee reviewed research and recommendations made by previous committees, and contacted members of the community familiar with Calvary's real estate. This information, informed by the Ministry Strategy Committee priorities, led to a search for a real estate solution that supports Calvary's ministry priorities, is financially feasible, carries the least amount of financial and operational risk, and is the least disruptive option possible.

With those parameters set out, and having contacted various members of the Beach real estate and development community, in April 2023, the congregation voted in favour of accepting an offer to purchase a portion of the land at 72 Main Street owned by Calvary. While this offer is conditional, and it will likely take until 2026 before we receive funds, this is a significant step towards aligning our real estate with our needs that will also provide the church with financial stability once the transaction concludes.

The progress made towards a sustainable financial model for the church began with prayer and discernment, which led to clarity on our ministry priorities, and has guided our decisions related to real estate. We continue to offer prayers of gratitude for being so blessed.
